

Avendus announces the launch of its third private credit fund, with a target size up to INR 4,000 crore

Avendus PE Investment Advisors, an asset management arm of Avendus Group, announced the launch of Avendus Structured Credit Fund III (ASCF-III), the third private credit Category II Alternative Investment Fund. ASCF-III is targeting a total corpus up to INR 4,000 including a green shoe option of INR 2,000 crore.

ASCF-III will primarily invest in secured credit transactions of both operating companies and holding companies, with select investments in hybrid structures based on specific deal requirements. ASCF-III is a sector-agnostic fund with a focus on industries such as pharmaceuticals, healthcare, manufacturing, consumer, chemicals, technology, B2B businesses, among others. The fund aims to build a well-diversified portfolio of 12-18 transactions with a target gross portfolio IRR of 16%-18%. It targets mature and growth-oriented companies with strong business models, and their promoters, addressing their capital needs through customized structured credit solutions.

Kaushal Aggarwal, Co-founder, Avendus said, "We are deeply committed to growing our Asset Management business. This platform is built leveraging the core strength of the franchise i.e. deep sector expertise and extensive corporate relationships, with a focus on identifying large high growth strategies. This approach enables us to offer differentiated investment opportunities ahead of the curve while delivering attractive outcomes for our investors. Our Private Credit Funds serve as a prime example of how we are able to scale up a strategy significantly with sustained focus and deep capabilities."

It has over 8 years of investment experience through its NBFC and Funds with total investments of INR 6,000+ crore across 100+ deals.

As the private credit market matures, it offers both investors and businesses a newer avenue to achieve growth and strategic adaptability in an increasingly sophisticated financial ecosystem."

We believe this is an opportune time for us to scale this strategy significantly given the increase in private credit demand from both investors and companies. With ASCF-III, we plan to focus on larger deals and businesses with typical deal sizes between INR 200 – 500 crore, along with leveraging Avendus Group's strength of having proprietary

access to corporates for origination. Combining a specialized multi-faceted underwriting approach with active risk management has enabled us to deliver strong risk-adjusted returns for our investors over multiple cycles."

ASCF-I, which launched in October 2017 was fully deployed across 9 transaction and returned the full capital back in June 2022, achieving a gross portfolio IRR of 18%. ASCF-II, which launched in January 2022, is fully deployed across 14 transactions, tracking an expected gross portfolio IRR of ~17%.
